Proposed Change to Constitution re Life Membership

3 (iv) Honorary Life Membership can be conferred on a member by a recommendation of the Management Committee to the Annual General Meeting for approval by 75% of the attendees voting through a secret ballot. The following conditions must be met.

- a. The member nominating another member must have been a member of the Silver Fawn Club for a minimum of the last 10 years.
- b. The member nominated for Honorary Life Membership must have been a member of the Silver Fawn Club for a minimum of the last 10 years.
- c. The member making the nomination of another member for Life Membership must do so to the Secretary of the Club by 31 December of any year to give the Management Committee sufficient time to consider the application, make a determination and give notice of the proposal to members within the approved time-frames for the next AGM.
- d. Any member nominating another member for Honorary Life Membership must provide the reasons (supported by evidence where possible) as to why they feel the member should receive Honorary Life Membership.
- e. The Management Committee will consider the application using the following criteria, in addition to the "10+ years continuous membership" rule mentioned above:
 - *i.* Demonstrated (evidence of) commitment to the ideals and ethos of the Club. *ii.* Committed service to the Club either on the Committee or in some other important sphere of its operation.
- f. ALL nominations for Life Membership MUST be taken to the AGM for discussion and voting by secret ballot regardless of whether or not the Management Committee is prepared to recommend the nominated person for Honorary Life Membership.
- g. If the Management Committee does not support the nomination, this will be advised to the AGM and the member who made the original nomination will be given the opportunity to state their reasons for making their nomination, prior to the secret ballot being taken.
- h. The AGM can approve a maximum of 2 members for Honorary Life Membership at each AGM. Where there are more than 2 nominees for Honorary Life Membership, the Management Committee will make a recommendation accordingly for consideration by the AGM. Where needed, a secret ballot will be conducted to select the maximum of 2 members for that year.

MINUTES OF THE 49TH ANNUAL GENERAL MEETING OF THE SILVER FAWN CLUB INC. HELD ON 7TH MARCH 2020 AT THE NEWSMARKET BOWLS CLUB, 212 ASHGROVE AVENUE, NEWMARKET.

ATTENDANCE: 51 members as recorded in the Attendance Register.

APOLOGIES:

David & Sandra Garth, Roland and Aloma de Mello, Jayantha and Lalani Pathikirikorale, Lakshman and Bernadette James, Camille and Alistair Gonsal, Marina and Trevor Ebert, Cherry Schokman and Carylle de Rozairo.

WELCOME/OPENING:

The President Herbert Tucker opened the meeting at 6.15pm, welcoming all members and guests. A One-Minute Silence was held for Members who have passed away in the last 12 Months - Leslie Ephraims, Sidney Shedden (ex-Presidents) Vilma Ghouse, Dorothy Baines, Alan Conderlag, Maurice De Rozairo.

The President advised the Meeting that the AGM will be chaired and conducted by the Secretary, Laurensz Manricks.

PREVIOUS AGM MINUTES AND MANAGEMENT COMMITTEE REPORTS:

The Secretary advised that the Minutes of the 48th AGM held on 9th March 2019 were published in the last Silverscene Newsletter. Laurensz Manricks moved and Gerard Fernando seconded a motion that these Minutes be accepted. Carried.

The Secretary advised that the 2019/2020 Management Committee Report was also published in the last Newsletter. Laurensz Manricks moved and Ray Anthonisz seconded a motion that this Report be accepted by all. Carried.

PRESENTATION OF THE ACCOUNTING STATEMENTS FOR THE YEAR 2019/2020.

Treasurer Susan Fahir presented the 2019/2020 Audited Financial Statements, stating that the Club's finances were in a healthy and sound position. She noted the following items:

- The Club made a net surplus of \$2,608 for the 12 months ending 31 January 2020. This included \$1,916 from the Food Fair, which was specifically a fundraiser to subsidise the 50th Anniversary celebrations. The Club also received 2 donations from members totalling \$550. These aside, the Club made a very small surplus for the year of \$142.
- A summary of functions with detailed income and expenses was also included in the Statements. The Annual Camp and the Anniversary Dance made a surplus of \$1,774 and \$1,362 respectively.
- Total income for the year was \$6,947 which included \$2,466 collected to subsidise 50th Anniversary functions in 2020. This represents a 39.2% increase from the previous year's total of \$4,990.
- Total Expenses for the year was \$8,402 which is a 11.4% increase from the previous year's total expenses of \$7,539. The 2019 AGM cost the Club \$1,310 nearly \$500 more than the previous year due to the record attendance.
- The only current Liability is the Auditor's Fee of \$500.
- Cash at bank at 31st January 2020 was \$7,771 and term deposits totalled \$18,276. Total current Assets are \$26,047.
- The 2018 Committee agreed to donate \$10,000 towards the 50th Anniversary dance to be held on the 20th June 2020.

The Treasurer moved and Andy Weerasinghe seconded a motion that the financial reports be accepted by all. Carried.

Annual General Meeting

The AGM was held on March 7, 2020 at the Newmarket Bowls Club with 51 members in attendance. There being only one nominee for each position, the following members were duly elected:
