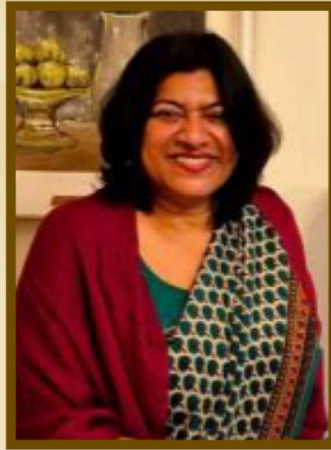

## Introducing the new committee

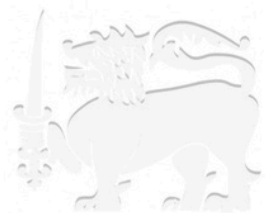

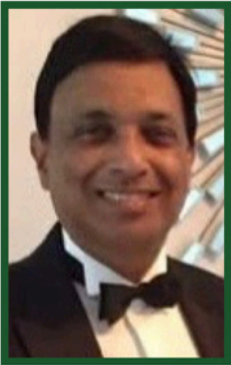

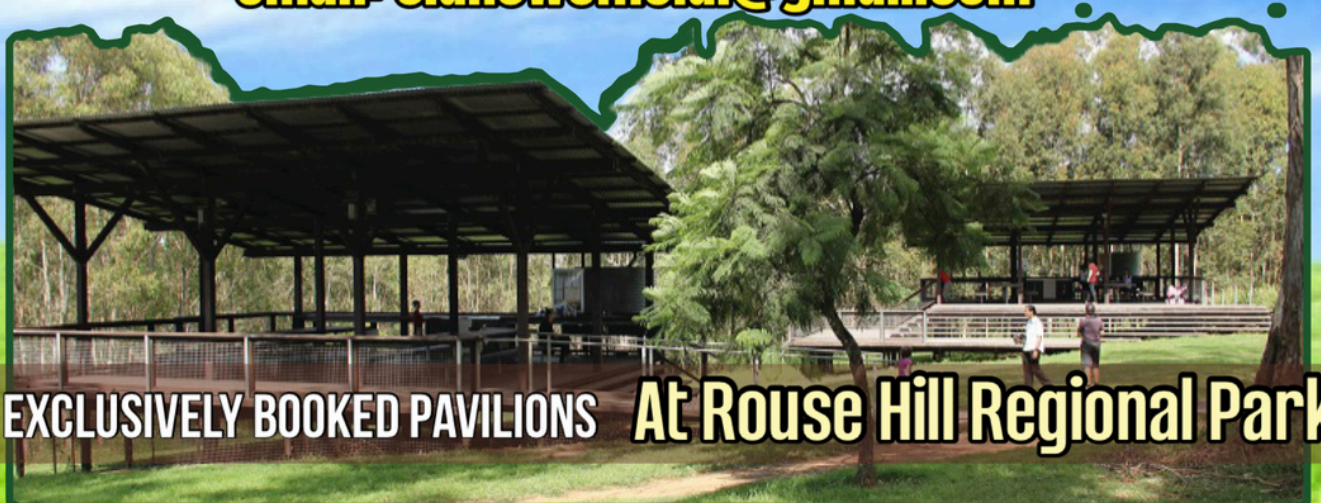
